PHASE 2: Deadline - April 28, 2017

Eligible NEW VEHICLE Purchase from OEM Dates:

January 1, 1998 to at least August 10, 2016

If you purchased one or more new motor vehicles from an OEM at any time between the dates above, you may be owed a payment per vehicle purchased from a group of settlements reached in *The United States District Court for The Eastern District of Michigan Southern Division*, No. **12-md-02311**

Who is eligible for Dealer Actions?:

These settlements pertain to antitrust allegations against a variety of auto parts manufacturers litigated in Federal Court. Dealer eligibility is based upon the concept that new vehicles contain these auto parts, some of which may be manufactured by the defendants. As a qualifying Dealer, you or your company may be entitled to a cash payment for **ANY new vehicle*** received from an OEM during the 18 1/2 year time frame; provided the acquisition was made in a qualifying state.

Why are these funds available?:

The Settlements are the result of litigation in Federal Court regarding antitrust allegations among a large group of auto parts manufacturers. Because these types of parts can be found in all motor vehicles, the costs of new cars to Dealers may have been adversely affected during the time frame of the alleged conspiracy. As a result, Dealers may have paid more for their new vehicles than they normally would have. The lawsuits allege that Dealers were unable to pass on all of these increased costs to their customers.

Dealer Purchaser Class

Generally, All persons and entities who, between January 1, 1998 and at least August 10, 2016, who either (1) bought one or more new motor vehicles* in a qualifying state in the U.S from an OEM, or (2) purchased one or more of the motor vehicle new replacement parts listed in the litigation. Excluded from the class are defendants; their parent companies, subsidiaries, and affiliates, any co-conspirators, all governmental entities, all persons who purchased their motor vehicle parts directly from the Defendants or for resale.

Types of products that may qualify

1) New Motor Vehicles:

**Include but not limited to automobiles, cars, light trucks, pickup trucks, crossovers, vans, mini vans, and sport utility vehicles*

2) Qualifying Replacement Auto Parts

Two ways to claim:

a) Actual data

b) A calculation based upon New car purchases

Number of Vehicles Purchased

The amount a dealership may be entitled to under these settlements will depend on the number, make, and model of vehicles purchased during the relevant period. To show how many vehicles your dealership(s) purchased, please submit the year-end OEM financial statements for each OEM from which you purchased new vehicles for each year in the states listed above from 1998 to 2016 (you may provide a year-to-date statement for 2016), AND provide a comprehensive summary by year of all makes and models.
